For the first item, it would take about 2 -3 weeks to quote... and we would need very specific information from you regarding the needs of the system, which we would need to arrange a meeting with knowledgeable staff members at Kozloduy to get the necessary information. Please see the attached system considerations to get an idea... and we would need to know VERY specific information about the scale you want to interact with this and find out if the software is compatible.

For the 6<sup>th</sup> item, the stanchions with the retractable ribbons, that requires a similar amount of information, but would be easier. It would take about a week, maybe a little longer to quote and we would need the following information:

- The number of stanchions required
- The length of the ribbon
- The custom wording required and spacing – and yes, we can create in the Cyrillic alphabet
- The attachment method required for the ribbon (magnets, hooks, clips) and what they would be attaching to – do you need attachment points for walls, other stanchions, etc?
